The Principal is informed that in case of non-receipt of the above particulars, it will be presumed that there is no surrender of Management quota seats and eligible Government quota seats pertaining to each branch as per 2018-19 AICTE sanctioned intake will be included under Single Window Counselling.

The Principals are informed that the details of seats surrendered will be considered final. No request for Withdrawal / Additional surrender will be entertained. Therefore the Principals are requested to finalize the seats to be surrendered and accordingly furnish details.
